Glenn has held senior leadership positions in financial services and investment firms, most recently serving as Managing Director of Shearwater Capital, where he leads proprietary capital strategies, drives corporate finance strategies as well as capital raising initiatives. He is also a Non-Executive Director of Xago Technologies Proprietary Limited, which focusses on digital asset infrastructure. Previously, Glenn was Head of Alternative Investments at Capricorn Asset Management, leading Namibia's largest private debt fund investments, and Head of Corporate Finance at Capricorn Group Limited, where he led mergers, acquisitions, and strategic investment initiatives across Namibia, South Africa, and Botswana.

With deep expertise in financial structuring, valuation, and capital markets, Glenn brings valuable strategic insights to Numeral Ltd and his appointment strengthens the Board's ability to guide the Company's growth, investment strategy, and capital allocation decisions.
